AHO Deadly Deposit Grant Application Form

This grant is intended for **Aboriginal people living in social housing** who are in the process of purchasing a home to acknowledge the work that has already been done in saving for a deposit. The grant is awarded at a \$1:\$1 rate to match peoples existing deposit savings and capped at a maximum of \$10,000 per successful application, which is paid on settlement of a property.

Please note that the main applicant must be Aboriginal and take on at least 25% ownership of the property being purchased.
